

Charles Yuspeh (#842) was awarded a "FIRST" also at ROMPEX for his "2¢ Washington Regular 1922-1929".





FLAG CANCELLATIONS

Wm. P. Barlow (#381) a recognized authority on these Cancellations, states that Micanopy is, indeed, an unlisted town and calls attention to the practice of using the same machine at more than one town. The Flag Die, as distinguished from the town name dial, normally stayed with the machine from its original manufacture until sccapped. He has matched the Micanopy die with an earlier use from Lake Wales, Fla. Incidentally Lake Wales has used more than one Flag die.

A Drop Letter in Milwaukee, Wis., franked with a copy of #85B, the Black Jack with Z Grill. In addition to the normal cork cancellation and the double-lined townmark with the date Jul 26, nyd, the cover is marked with a very fine "Not Called For" in tombstone form, and a further handstamp, "Milwaukee Wis. Advertised Jul 31." On the reverse is yet another circular datestamp, Sep 11, and the cork killer, probably the date the letter was picked up. There is nothing to indicate that any charge was made for the advertising. There is no year date in any of the handstamps, but since the grilled stamps made their first appearance in August, 1867, this probably indicates an 1868 date for this cover. There are no contents.
