#### SEPAD REQUESTS HELP FROM USCC MEMBERS

The Associated Stamp Clubs of Southeastern Pennsylvania and Delaware (SEPAD) are holding their annual exhibition this year at the Sheraton Hotel Exhibit Center in Philadelphia from November 5 to 7.

The cacheted covers will picture the cars used in transporting the mails over the Street Car RPO system which operated in Philadelphia from 1895 to 1915.

As a companion to the cacheted covers, USCC members Wylie Flack and Bob Stets are preparing a brochure describing the operation of this system. It will be available at the show and later at a nominal price to those who are interested in this nostalgic period in Philadelphia(s Postal History.

However, we want to include as much information as possible on the various types of cancellations used on these routes, and we are asking members of USCC to send .hotocopies of covers or postcards in their collections which bear these interesting markings.

At the present time, nine different route markings are known, with one or more different types for each route:

H & P R.P.O. (Station H to Station P) Phila. & Manyunk R.P.O. (GPO to Sta. 1)

Phila. & Germantown R.P.O. (GPO to Sta. G) Phila. & W. Phila. R.P.O. (GPO to Sta. B)

Phila. & Woodland Ave. (GPO to Sta. U) Phila. & Darby R.P.O. (GPO to Darby via Sta. U) Phila. & Frankford R.P.O. (GPO to Sta. F) Southwest Circuit R.P.O. (GPO to GPO via Sta. D&P)

Phila. & Chestnut Hill R.P.O. (GPO to Sta. H)

We are particularly anxious to see markings of the West Phila., Woodland Ave. and Chestnut Hill routes.



#### E. S. MILLER of Newark, Ohio, Manufacturer of postmarking stamps by Delf Norona (#62)

On page 17 of the May, 1970 NEWS an item from the collection of Pat Herst is illustrated showing the postmark of PHILLIPS STATION/NEBRASKA /SEP I 1884, together with various axuiliary markings obviously of that office.

During the mid 1880's and 1890s there were a number of postmark manufacturers, catering chiefly to the needs of smaller post offices. One of these was the firm of E. S. Miller, who advertised himself as "Flexible Stamp, Stencil and Printing House NEWARK, OHIO." He ran an ad, on page 5 of the annual, January, 1884, issue of the U.S. Official Postal Guide, illustrating a townmark identical with the PHILLIPS STATION handstamp show from Pat Herst's collection. It is probable that Miller made the postmarking stamps illustrated in the May, 1970, NEWS.

Now, the post office of PHILLIPS STATION, NEBR., was established some time in June of 1884, so it is quite possible its postmaster, J. O. Baker, ordered a supply from Miller, soon after his office was established, and either he or his assistant, Minnie Baker, tried them out on a sheet of paper.

Turning to the July, 1971, NEWS a fascinating cover from the collection of Richard H. Schwinn is shown on page 78. This envelope bears an impression H. M. MADDEN. NIGHT LINE, MAY 30 EAST 1889...at the top of the cover and adjacent to the illustrated corner-card of E. S. Miller, the same miller who probably made the handstamp PHILLIPS STATION, NEBR. This particular oval handstamp is not pictured in advertisements of the U.S. Official Postal Guides of the 1870s to 1890s.

Now, the One Cent Franklin stamp (denoting a circular rate) on the envelope bearing the Miller illustrated corner-card is obliterated with what is obviously a cork or wooden canceler, whereas the R.P.O. townmark H. M. MADDEN, etc., is exceptionally sharp and clear. There is also a curious handstamp in the lower portion of the envelope "New Office just established."

After studying the illustration, it was our supposition that the H.M.MADDEN townmark was <u>printed</u> as part of the advertisement of the Miller Company. This was further done to advertise his products.

What Miller did was regularly to go through the monthly editions of the U.S.Postal Guides as they appeared (which listed new offices established, with the name of county and state.) When the Preston, Sonoma Co., Cal. post-office was established (first mentioned in the April, 1890 USPG) he sent a circular which did not need to have a town mark. a mere blob of a cancellation was all that was required as was done in this case. This could be determined by seeing the cover and ascertaining that the H.M.MADDEN reproduction of a R.P.O. postmark was <u>printed</u> on the envelope and in the same color exactly as the rest of the advertising corner-card, in other words, a part of it. It did not serve the function of a postmark applied by the postmaster.

On corresponding with Mr. Schwinn, he confirms my deductions and states that both the corner card and the handstamp are indeed both in the same shade of black. The auxiliary handstamp "Post Office just established" is in a reddishpurple. Schwinn further states that the cover is backstamped CLOVERDALE, CAL. MAY 27. Both Cloverdale and Preston are in the same county of Sonoma, Cal. The Cloverdale is undoubtedly a transit marking, the letter going to Cloverdale on its way to the newly established post office of Preston.

Note that the cover is addressed to the postmaster by name, "Wellington Appleton, P.M." The Preston post office was opened in April. Miller may have first sent a circular advertisement sometime in April or early May, 1890. The postmaster may have responded, giving his name, and then the cover in question was sent enclosing a second circular, some few days before the backstamped date of May 27th. The USPG doesn't list names of postmasters.

The rubber stamp "New office, just established," is probably not a postal marking applied by an agency of the P.O.D., but a private emission by E. S. Miller, to call attention to the postal officials that Preston was a newly opened office, otherwise someone along the line might consider it a "No such office in state named" and consigned it to oblivion or to the Dead Letter Office.

To our mind, such a private handstamp is really more interesting than if it has been a product of the P.O.D.


#### LIBRARY



#### COMPEX 171

At the suggestion of Mr. Thomas E. Elnen (#578) who was one of the Vice-President of COMPEX. USCC sponsored a section of Exhibits offering Trophies and also supplying the most interesting and informative articles for the booklet. President Schoen appointed Mr. Elnen Chairman of the Committee to handle the details. Members responded in fine shape to his request for articles and for Exhibits.

Articles from nine of our members appeared, seven of them in the CANCELLATION DIVISION. the others elsewhere. Forty-four frames of Exhibits from six members and a friend were shown. Paul J. Wolf (#743) received the "GRAND AWARD" for his Auxiliary Postal Markings on Black Jack Covers". Pres, Robert H. Schoen(#384) had a Reserve Grand Award for his "Selection of Pages from a Bank Note Collection featuring Fancy Cancels as did Elaine R. Strauss (a friend) for "A Selection of Pages from a Specialized Collection of Chicago Street Car Railway Post Offices illustrating most known Markings with emphasis on Die Varieties". A Gold Medal went to William H. Bauer (#834) for "Denver, Colorado: A Chronology of Cancellations. The Progressive Changes in Cancelling Devices from the Handstamps of Denver City and Denver to the 20th Century Machine Cancels of Denver". Silver Medale were awarded to Orville Mohr (#744) for "A Selection of U.S. Star Cancellations showing Many Types used in the 1860-1890 Period", to Daniel M. Knowles (#828) for "A Selection of U.S. Fancy Cancellations on the 3¢ Definitive Stamp of 1861 and to Paul E. Smith (#811) for "A Selection of U.S.World War I Soldiers' Mail: American Expeditionary Forces-Covers from Siberia and European Theatre of Operations".

The Articles included the following in the USCC Division: 1861 Issue Postage Due Covers by Thomas E. Elnen: Postage Due Markings in the Black Jack Era by Paul J. Wolf; Star Cancellations by Orville Mohr: U.S.Machine Cancellations by Arthur H. Bond: How to Collect Fancy Cancellations by Daniel Knowles: the Leavitt Machine Cancellations by Frank B. Stratton; Colorado Stars, A Preliminaary Discussion by William H. Bauer. In the Alaska Division there were three articles by Paul E. Smith, "Alaska Dog Team Mail", "The Alaska Railroad" and Idatarod, Alaska". Gaspare Signorelli (#368) wrote a special article on "Collecting and Recording".

President and Mrs. Schoen were in attendance through the whole show arriving in the A.M. of the 28th and remaining until all was over. Due to some unpleasant personal problems Mr. Elnen was unable to spend as much time there as he and we had hoped. Also for the same reason delivery of the awards has been delayed but he assures us they will be arriving soon. A meeting for USCC Members was scheduled for II:00 A.M. on the 30th. President Schoen called it to order at II:03 with four members there. Thomas J. Wisniewski(#727), Ruth Grissman(#667). Daniel Knowles(#828) and J. Stanley Thompson(#439). Mr. Schoen made the report sent him by the Secretary and then a number of subjects were discussed, Those who were there certainly managed to carry away a few new ideas.

A thought has been advanced that USCC might wish to become a part of COMPEX again. Of course, if we are invited, the decision will have to be made by the next slate of officers and the next Board of Governors, those who take office on Jan, I, next. Probably a decision on that question should be made shortly after the first of the year. Chicago is about as central as one can get in the USA and perhaps, as we grow larger, it might be wise to try something like this each year.

The report on the finances of the show will have to come later when all expenses are in and paid.
