

FRONT PAGE

The cancellation shown on the Front Page(#1) positively identifies the town of usage of this interesting killer as Coldwater, Michigan. In his exhaustive study of the 2¢ Red Brown of 1883-7, Willard listed this cancellation as No. 420, but was unable to identify the origin or a town of usage. He noted that the cancel is rather common. but eliminated Ed, Tennessee as a possible source since there is no listing for such a town in the Postal Guide for 1887.

This cover has no manuscript docket or backstamp that would determine the year of use. However, another cover addressed to Coldwater from Detroit was included in the lot in which the former was found. The second item has a Coldwater receiving backstamp dated November 13, 1883, twenty-two days before the item of interest. The two probably represent an exchange of correspondence.

The stamp franking the cover photographed is dark metallic red in color. This fact provides additional supportive evidence of the 1883 usage. Mr. Willard notes that dark metallic red was the prevalent color of stamps issued between October 1, 1883 and March of 1884. The writer also has a dark metallic red copy off cover with the ED cancel. It is suggested then, that the ED killer was used at Coldwater, Michigan in 1883.

Willard further speculates that perhaps ED was a postal clerk somewhere. Indeed, Edward R. Root was not just a postal clerk, but according to Post Office records in the National Archives. he was appointed postmaster at Coldwater, Michigan January 30, 1882, and undoubtedly designed the killer with his nickname in celebration of the event. The "Official Register of the United States, Vol. !!" notes the Coldwater postmaster's annual salary was \$2,200 and that there were three clerks. Craws Atlas of 1887 lists a population of 5102 for Coldwater, then County Seat of Branch Co., Michigan. Root continued in his capacity until February 19, 1886 and it would be interesting to determine just how long the ED killer was used. Readers having covers, stamps or other information are invited to correspond with the writer.

I would like to thank Mr. Willard for his comments and the additional background detail he provided. --Larry K. Shick (#947)

The Cover shown on the front Page (#2 is from the Collection of Mr. Alton Gaumer (#909). It is illustrated because of the unusual arrangement. Note the "P.M." above the month. Also Mr. Gaumer states that it is the earliest marking he has seen in a handstamp differentiating between "A.M." or "P.M." in a dater Canceller.

A few new discoveries are illustrated above so that they may be inserted in the handbook. The interest aroused by this book among collectors has resulted in the reporting of numerous additional markings for specific post offices. USCC WILL MEET AT COMPEX

The USCC has been invited by the Chicagoland Czechoslovak Society to exhibit and meet at COMPEX. The COMPEX show is generally an excellent event, one of the largest in the Chicago area yearly. The theme of the 1973 show will be worldwide postal history. It is thus very fitting that we exhibit and show some outstanding cancellations and postal markings. COMPEX will be held May 25-27 at the LaSalle Hotel.

The amount of frame space granted us is smaller than we would like and USCC members who desire to exhibit should get in contact with the exhibition chairman immediately as the frames will go on a first come first serve basis. The frames are large, holding 9 standard $8\frac{1}{2} \times 1!$ pages or 6 of the larger Elbe-type pages. They shall cost the membership \$2.00 each, a very reasonable fee. We will allow any member to enter up to two exhibits but each exhibit must consist of no less than I frame and no more than 6 frames.

One of the special features of COMPEX is their massive directory in which they always publish several articles by members of the participating clubs. This is an excellent opportunity for any USCC member to write an article about any phase of his collecting interests. Photographs are allowed and encouraged. All articles should be on $8\frac{1}{2}$ x II paper, neatly typewritten and double spaced. Photographs should be enclosed with clear indication of their place in the article and the appropriate legends also indicated.

A nice advantage to participation in a midwest show is that your central position alicws more members to attend the meeting. The USCC will meet at COMPEX. Naturally, business will be discussed but much of the time will be spent in meeting old friends and making new ones. We hope as many members as possible can attend the meeting, the exact date, time and place of which will be clarified at a later date.

On Page 56 we show two more interesting "Black Jack" Covers from the Coilection of Mr, Paul J. Wolf (#743). #1 is A New York drop letter. probably mailed with the 1¢ #63 only. Since the Drop Letter rate in New York City was 2¢, the letter was marked "Held for Postage" in blue oval, and an official request made for the i¢ needed to make up the normal drop rate, and 1¢ as penalty for the shortage. When the Black Jack was furmished, or herpahs the money equivalent, it was added. partly over the "Held for Postage" marking, both stamps cancelled. and it was delivered. Perhaps it is of interest that A. T. Stewart was one of the early Department Store owners. seiling out, at a later date, to John Wanamaker.

#2 is a printed envelope for the 100th Indiana Volunteers, postmarked Indianapolis, 8 Sep 64, and with a "Due 2" in circle marking both in the distinctive blue- green ink favored by the Indianapolis Post Office at that time. The franking, a single Black Jack, was a penny short, so the Post Office dutifully collected the shortage, and a 1 cent penalty.

MEMBERSHIP COMMITTEE REPORT by Daniel Knowles (#828)

In recent years, due to decreased interest in the promotion of our Club through the available media, USCC has not only failed to increase its membership but had actually lost members. Thus, after peaking at 344 members in the 1970 Roster we drifted down to 325 on the 1972 Roster. The Membership Chairman is delighted to report a complete reversal of this trend. We have added 95 new members, losing !! and dropping 13 for non-payment of dues. leaving us with a net increase of 71 members or 20% of the total membership.

The Membership Chairman was directly responsible for the addition of 27 members, 6 requested reinstatement and the current membership sponsored 62 other newcomers. Several available media were employed by the Membership Chairman to successfully publicize the USCC. A single brief article appearing in STAMPS. LINN'S WEEKLY and WESTERN STAMP COLLECTOR added 20 members. An even shorter mention in the CLASSICS SOCIETY BULLETIN and the POSTAL CARD SPECIALIST added 5 more. A little publicity goes a long, long way.

The Membership Chairman personally feels that increasing the membership is a very important Club activity that should involve all Adding new blood to the Club adds new members. material to the circuits, new buyers for that material, new contributors to the NEWS and, through dues, increases the general treasury so that projects such as the publication of the BOND Books can be financed.
