A considerable rarity is this Lake Champlain S.B. (Steamboat) cover. Scarce even with the more common 3¢ #65 franking, with the Black Jacks it is choice! The pair of Black Jacks are cancelled by a 6-ring target killer, and the Route Agent's marking takes the place of a townmark. The accompanying letter is dated from Ticonderoga, so it was undoubtedly handed to the Route Agent aboard a Lake Champlain steamer at that point. It went to Whitehall, at the Southerm end of the lake, and by stage to Troy, from there.

A two- part article on the Lake Champlain mails entitled "U.S.-Inland Waterways" by Dr. Donald B. Johnstone, appeared in the May and September 1972 issues of the Postal History Journal, and gives a rather complete picture of an unusual service. THE U S CANCELLATION CLUB NEWS

BARR-FYKE MACHINE CANCELLATIONS

by Arthur H. Bond (#505)

From January to September 1969 the USCC NEWS contained a series of articles by this writer on the above subject which was later incorporated in a booklet sold to collectors in this specialized field. Since that time considerable additional information has been obtained through the kind co-operation of collectors. This is being published here so that interested collectors may add it to their records.

The latest known date of use of a Barr-Fyke machine is Dec. 3, 1905. We now have 24 machines recorded as used in 1905. Two covers have been seen in which, instead of being named, the month is represented by a numeral, after the "Quaker dating" fashion. This occurs at Kansas City, Mo. 4-30-1900 in Type C-121 and at Tacoma, Wash. 9-11-1901 in Type Ca-122, the year dating being omitted in the latter instance.

ERIE AND KALAMAZOO RAILROAD April 22, 1972

The Erie and Kalamazoo was incorporated April 22, 1833, 139 years ago today. On the morning of November 2, 1836 the first car to run on this railroad departed from Port Lawrence, to the boom of cannon, arriving safely at Adrian several hours later. Horses pulled the car and were driven tandem, with relays every four miles. It was the first railroad to operate west of Schenectady, New York. The first passenger coach on the Erie and Kalamazoo was called a "pleasure car," a top-heavy affair with ornamental openings that made it look like a traveling chapel. Later passenger cars were provided with benches along the sides, and the entrance door on one side. Double-decker coaches also were used, the upper deck being furnished somewhat more lavishly than the lower deck and reserved for ladies. In 1837 the Erie and Kalamazoo received at Toledo a locomotive manufactured by the Baldwin Works in Philadelphia. This was the first locomotive to operate on a railroad west of the Alleghenies.

In 1849 the directors of the Erie and Kalamazoo leased its right of way to the Michigan Southern Railroad, now a part of the New York Central System, for \$30,000 a year, forever. Every year the stockholders of the Erie and Kalamazoo meet in Adrian, the directors declare a dividend, and the meeting adjourns—surely a pleasant way to run a railroad.

I HISTORY

Some years ago, the wild burros gathered in a valley of the Nevada desert about 90 miles Northwest of Las Vegas. Here, on the relatively flat plain between Skull and Shoshone Mountains, the burro found abundant forage. It was in the mid 1950's that man came to Jackass Flats, and a radical change in the desert landscape began to drive these gray brown ghosts away to seek other hunting grounds.

By 1962, a rather extensive complex of concrete and steel dotted the landscape. These buildings and test facilities resulted from a joint agreement that had been executed by the National Aeronautics and Space Administration (NASA) and the Atomic Energy Commission (AEC) which established a Nuclear Rocket Development Program. The original agreement was signed by John A McCone (chairman, AEC) and T Kieth Glennan (Administrator, NASA) on Aug 29 and Aug 26, 1960 respectively. The Nuclear Rocket Development Station (NRDS) was established by an Interagency Agreement signed in Feb 1962, by R Luedecke (General Mgr, AEC) and R Seamans, (Associate Administrator, NASA).




Fig 1 Regional Vicinity Map

A regional vicinity map of Southwest Nevada/California is shown in Fig 1. The NRDS can be seen in outline form.

JACKASS FLATS

On page 78 we show a page from a monograph on Jackass Flats by Bart. J. Billings (#873)

As you know this was the site for many tests of nuclear explosives but has been closed. Since Mr. Billings was a part of this operation he has decided to make a record of it which would be available to others.

It consists of 20 pages of reading matter and illustrations including covers from the Post Office which was established there when the need arrived. The "Cover-Folder" is attractively prepared. SALES DEPARTMENT

Two factors are operating against the orderly progression of our circuits. The first is too long delays by some members of the groups. To correct this it is necessary only for those members who are at fault to make a serious effort to correct this fault. The cards of inquiry sent to those members should not be necessary. They are costly. The second cause is delays in the Post Office Dept. About this we can not do much except to be sure to wrap securely and to retain the Ins. receipt until the package is delivered. One other action which your sales manager has been trying is to use United Parcel Service instead of Parcels Post or third class mail. This has some advantages as well as some drawbacks. First the advantages: 1, Delivery usually is quicker. 2, Price per package usually less. 3, They pickup. 4, Packages can be insured for full value. The disadvantages: 1, No service West of Colo. 2, We do not know whether the rules are the same everywhere or not but in Denver rates are figured according to Zip code #s and an additional charge of \$2.50 is made each week for pickup. Obviously it is necessary to ship a number of packages each week to spread this charge out enough to reduce the price to the level of Parcels Post or 3rd class. Any member living in the states served may use UPS if more convenient. If so insure for full value and note the fact on the report blank as justification for neglecting to pay the extra 35¢ for insurance over the P.O. limit.

Recently two valuable circuits have been lost in the Los Angeles area. Although the P.O. accepted the responsibility and the \$200.00 limit in both cases the losses cost our Insurance fund several hundred dollars. Therefore we have asked members of that group to deliver by hand if possible or to register declaring full value.

As this is written 38 circuits are out. Given the necessary material we probably could keep about 45 going all the while. Reasonably priced Postal History items sell well. More could be used. Digitized by https://stampsm

NEW NEVADA POSTAL HISTORY PUBLISHED

Nevada Postal History specialists, ghost town fans, travel and history buffs will welcome the just published NEVADA POSTAL HISTORY by Robert P. Harris. This hard bound volume contains a compilation of openings and closings of all Nevada Post Offices since the first opened at Carson Valley (now Genoa) December 10, 1852.

Himself an ardent collector of Nevada Postal items, the author has placed valuations on all the discontinued post office cancels. Several rare covers are illustrated.

A valuable section is devoted to the Nevada Railroad Postal Routes, and 43 such routes are listed. In addition state boundaries are discussed as relating to the post offices.

Perhaps the most valuable feature of the book is a $17\frac{1}{2}$ "xx. Q4" map folded into the back of the book. Harris has located all but 4 or 5 of the approx. 730 Nevada post offices on this map. Many of these P.O. locations have been 'lost' for many years.

The GARDEN CITY WATERMARK


