CIRCUIT MATERIAL IS NEEDED, HELP! HELP!

During the past year Dan Stone has been acting as secretary and attempting to return circuits to those members who requested return of their material. Consequently there has been a depletion of 19th century circuits to send out to the various members. If there are any members in the organization who would help us revitalize the circuits with new material, it would certainly be a great boon to the club.

Sales Booklets are available for those who need them from the new U.S.C.C. Office. Booklets with glassine pages for covers, twelve to a booklet for better covers are 20¢ each; booklets with pages for 120 stamps are 10¢ each; envelopes for insertion of up to 20 covers without glassines are 5 for 25¢. Please send requests as soon as possible. It is going to take the cooperation of every member to get us back on our feet.

Accounting for Existing Circuits

We are presently completing an audit of all circuits which are presently still in existence. It will be completed within the next week, so that circuits will be available for mailing to members.

However, there are still four circuits outstanding which have not been returned to the club. We would presume that the members having these circuits retained them awaiting word as to where to mail them. The address is now available, as stated above, and we would appreciate an immediate return so that we could complete the audit of funds.

In this regard we also note a number of instances where members have outstanding amounts due to material selected from the books that were circulated or for insurance when nothing was selected. It is again presumed that these amounts were held awaiting a definite place for which to remit the amounts due. While these amounts are often small, it is hoped that the members involved will send in the amounts due to avoid the necessity of the club expending both postage and time to remind you.

Owners and Sellers -- Please Don't Ask for Return of Your Books

The title tells it all. We do not want to return the books to you now. We need to circulate them to start our circuits again. We realize that prices may have gone up on some of the items. We further realize that you have waited well over a year and sometimes two years for your money. However, on the other hand, they could have been sold at the old price and you had only money coming.

So please wait. If you insist on their return, we will send them back (unless, of course, we had happened to send them out with the first new circuits -- and we may guarantee that will have happened). Seriously, we need them all, so help by not asking for a return.

SALES CIRCUITS ARE READY. ARE YOU?

Sales circuits are ready and will be mailed out to members desiring them as soon as boxes have been received from the manufacturer in which to ship such circuits. If you are not desirous of receiving circuits, please let us know as we will be shipping circuits in accordance with former records.

Do You Want 20th Century Sales Circuits?

In examining the circuit books presently on hand, we find that we have a plethora of twentieth century circuits. Consequently we could supply members desiring such circuits readily with a number of such circuits -- in fact it will take many months to get the circuits sent out because we have too many. Thus we would appreciate circuit requests from those members who definitely are interested in such circuits and have not been placed on the mailing list for such mailings.

First Day Cover Circuits

Once again there seems to be a number of books of first day covers (mostly post 1945) among the circuit books which have not been sent to even one member. Thus, if any member is specifically interested in first day covers, please let us know. If we have enough interest we will make up First Day Cover only circuits.

Oh! You Received that Circuit Before?

It's going to happen, and we apologize. As we revise the circuits to take care of present requests and changes since circuits were last mailed out, we are going to make errors. We are attempting to set up a better system (at least in our mind) outlining who is sent what, and when. It is extremely difficult to reconstruct presently from the records what has been sent to whom. The only factors that are evident are the last circuit mailings and a record of those who have not paid money owed to the U.S.C.C. Consequently, we will goof. We apologize. Please don't complain. Next year we will accept your complaints.

DUES -- 1976

The Board of Directors of the U.S.C.C., upon suggestion form Col. Bozarth, has agreed to forego the collection of dues for the year 1976. It was felt that the rebirth of the organization in May of this year corresponds almost to a year to the date in which last activity was noted. Consequently, it was felt that the balance of dues due for the year 1975 would be applied to the balance of the year 1976.

However, the organization would be happy to collect dues from those members willing to make a contribution equivalent for dues for the year 1976. It is felt that this approach is necessary because some members have already sent in their dues for 1976 unsolicited.
